

- Gender nonconformity is a <u>normative variation of human diversity</u>






Cisgender (Cis)

Transition

- Process by which an individual begins living in their affirmed gender
 - Social
 - Legal
 - Medical
 - May or may not include hormonal and/or surgical treatment

No one way to be trans; therefore, no one way to transition









Pronouns

It's okay *important* to ask people what pronouns they use

- they/them/theirs
- she/her/hers
- he/him/his
- other pronouns

Why is pronoun use so important?

- Golden Rule Platinum Rule
- Pronouns > Names
- Mutual Respect
- Affirming environments nurture positive growth
 - When LGBTQ+ young people are supported by a singular adult, the potential they will self-harm decreases by 40%

Transphobia/Cissexism

- Physical Violence
 - One in ten trans people reported being physically attacked within the past year due to their gender identity
- Microaggressions
- Systemic Discrimination
 - One in six trans people report having lost a job due to their gender identity; one-quarter report having experienced housing discrimination
 - <u>Restroom Access</u>



Discriminatory Legislation

Since 2021, <u>over 500 discriminatory</u> <u>bills</u> targeting gender-affirming care and youth athletic participation flooded the legislatures of 42 states, marking a historic high.





Discriminatory Legislation

- 85% of trans and nonbinary youth say that their mental health has suffered due to recent state-level attacks on trans rights.
- **44%** of trans individuals 18 and up experienced serious psychological distress in the last 30 days

Impact Points: Health

The survey shows the survey respondents experiences due to their transgender/non-binary identity:

- Public Restrooms
 - 4% were denied access to a public restroom (at work, school, or a public place). 6% had been verbally and/or physically harassed, physically attacked, or experienced unwanted sexual contact when accessing or using a public restroom.
 - 30% and 39% of respondents had been verbally harassed and/or harassed online, respectively, in the last 12 months because of their gender identity or expression.
- Employment/Financial Stability
 - 26% had at least one issue with their insurance company in the last 12 months, including, but not limited to:
 - being denied coverage for hormone therapy, surgery, or another type of health care related to their gender identity/transition
 - gender-specific health care because they were transgender
 - routine health care because they were transgender
 - 35% were experiencing poverty. The 2022 national rate was 11.5%.
 - 18% reported being unemployed. The 2022 national rate was 3.6%.
 - 11% of respondents who had ever held a job said they had been fired, forced to resign, lost the job, or been laid off because of their gender identity or expression.
 - 30% had experienced homelessness in their lifetime.



Harassment

- 9% reported that they were denied equal treatment or service in the last 12 months because of their gender identity or expression.
- 30% reported that they were verbally harassed in the last 12 months because of their gender identity or expression.
- 39% reported that they were harassed online in the last 12 months because of their gender identity or expression.
- 3% reported that they were physically attacked in the last 12 months because of their gender identity or expression.
- Self-Harm
 - 42% of trans adults reported having had ever attempted suicide
 - 56% have engaged in self-harm without suicidal intent
 - 31% reported problematic drug use
 - 28% reported hazardous drinking
 - Non-binary individuals were found to be four times more likely to drink in hazardous manner than transwomen and four times more likely to use drugs in a way they would describe as "problematic" than transgender women.



- Violent Crime
 - Four times more likely than cisgender counterparts to experience victimization.
 - 1 in 4 trans women attributed a victimization account as a hate crime, compared to 1 in 10 cis women.
 - Similar to the general public, about half of the victimization experiences are not reported to the police.
- Homicide
 - At least 33 instances of murders of trans individuals in 2023
